
The California Prenatal Screening Program

The California Prenatal Screening (PNS) Program is planning to make first-tier cell-free DNA (cfDNA) screening available to all pregnant individuals in California beginning September 19, 2022. The Genetic Disease Screening Program (GDSP) now provides a secure online web-based portal. It's currently available for viewing screening results and will be available September 19, 2022, to order screening tests. All physicians and their delegates are encouraged to log into the CalGenetic Portal (https://calgenetic.cdph.ca.gov) and set up an account now.
