

Call for Proposals Partnership & Stipend Opportunity for CNA Training Programs January 2025 – June 2026

The California Department of Public Health (CDPH) Healthcare-Associated Infections (HAI) Program oversees the prevention, surveillance, and reporting of HAI and antimicrobial resistance in California's hospitals and other healthcare facilities. As a Project Firstline site, the CDPH HAI Program partners with local and corporate skilled nursing facilities, local health departments, professional organizations, training programs, and others to:

- Offer infection prevention and control (IPC) education and training
- Share information about HAI and IPC practices
- Raise awareness of materials and resources designed to provide IPC training

Project Description

Fifty-five percent of recently surveyed Certified Nursing Assistant (CNA) training programs responded that IPC implementation and outcomes for students and staff would be improved by having a dedicated IPC practice space and additional equipment. In addition, 94% shared that a financial stipend from CDPH would be beneficial in obtaining needed training equipment and resources. To support CNA learning, the CDPH HAI Program is pleased to offer a partnership and stipend opportunity to establish or enhance IPC skills labs and curriculum in California CNA training programs. Stipend recipients will receive \$20,000 and recognition on the CDPH HAI Program webpage.

Application Process

The CDPH HAI Program will select stipend recipients via competitive application, with priority to those trainings programs that have expressed commitment to establishing or improving IPC curriculum (e.g., by using <u>Project Firstline IPC trainings</u>

(www.cdph.ca.gov/Programs/CHCQ/HAI/Pages/ProjectFirstlineCNAToolkit.aspx)) or are located in regions of the state where healthcare facilities may benefit from additional resources to improve health outcomes.

Project Timeline and Expectations

Stipend recipients will engage in a 1.5-year long commitment, and must participate in the following:

Phase 1: January 1- June 30, 2025

In Phase 1, the CDPH HAI Program will distribute stipends and support stipend recipients by providing one-on-one consultations to discuss training implementation strategies and needs. Stipend recipients will commit to the following:

- Maintain training program contact information to be included in the CNA training program distribution list.
- Agree to have their training program name on <u>HAI Program webpage</u> (www.cdph.ca.gov/Programs/CHCQ/HAI/Pages/ProjectFirstlinePartnerWithUs.asp x)
- □ Submit a W-9 and payout information for funds distribution. We will process stipends on a rolling basis; note that it may take up to four (4) weeks to receive your payment. Training programs forfeit their stipend if required forms are not submitted by the end of Phase 1 (June 30, 2025).

Phase 2: July 1, 2025- June 30, 2026

In Phase 2, the CDPH HAI Program will convene regular partnership meetings and provide ongoing consultative support. Stipend recipients will commit to the following:

- Maintain training program contact information to be included in the CNA training program distribution list.
- Document and provide progress updates to the CDPH HAI Program on a quarterly basis. The CDPH HAI Program will provide reporting templates for:
 - Skills lab development (e.g., purchased materials, number of staff hired to manage skills lab)
 - IPC training implementation (e.g., training structure, covered topics)
- Host an in-person or virtual *meet and greet* with CDPH HAI Program Project
 Firstline Nurse Educators. This is an opportunity to showcase training program
 efforts or host other activities based on training program interests.
- □ Attend *partnership meetings* to discuss training strategies, IPC successes, and best practices.
