- o Address, zip
- Start with "The Why?" 1:33 patients get infections, at top of annual report
- Comparison YOY baseline vs years since (The 2016 Annual Report was reviewed. The subcommittee said the background information on the 2016 report is good. The visuals of the report need updating. The subcommittee would like to see the current Executive Summary to be more accessible to the public.)
- Updated modern fonts: like mobile COVID daily reporting.
