NOTICE OF 15-DAY PUBLIC AVAILABILITY OF CHANGES TO PROPOSED REGULATIONS REGARDING CLINICAL LABORATORY PERSONNEL STANDARDS (DPH-20-007)

PUBLIC PROCEEDINGS: Pursuant to Government Code section 11347.1, notice is hereby given that the California Department of Public Health (Department) has changed the text of the proposed regulations regarding Clinical Laboratory Personnel Standards, Medical Laboratory Techician (DPH-20-007).
